Sub: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

In addition to our disclosures dated September 22, 2023, please note that Deltatech Gaming Limited, a subsidiary of the Company has received an intimation for payment of shortfall tax under Section 74(5) of the CGST Act, 2017 and West Bengal GST Act, 2017, from the Directorate General of GST Intelligence, Kolkata, on October 13, 2023, as set out below:

The notice advises Deltatech Gaming Limited to pay the alleged tax shortfall along with interest and penalty failing which a show cause notice will be issued to the Company under Section 74(1) of the CGST Act, 2017.

The amounts claimed in the abovementioned notice are *inter alia* based on the gross bet value of all games played during the relevant period. Demand of GST on gross bet value, rather than gross rake amount, has been an industry issue and various representations have already been made to the Government at an industry level in relation to this issue.

The notice also states that the CEO & Executive Director of Deltatech Gaming Limited, being in charge of its day to day affairs, is liable for a penalty under Section 122(3)(a) of the CGST Act, 2017 read with the West Bengal GST Act, 2017.
