1. I have given my consent to act as Scrutinizer vide letter dated April 18, 2025 and was appointed as Scrutinizer for Postal Ballot including remote e-voting by a resolution passed by the Board of Directors on April 22, 2025. Further, the Company Secretary of the Company is authorized by the Board for conducting the postal ballot process.

- 2. The Company has completed the dispatch of the postal ballot notice through email on April 29, 2025 to its members whose names appeared in the Register of Members / Records of Depositories as on April 25, 2025.
