- The above audited results for the Financial Year ended March, 31, 2015, were reviewed and recommended by the Audit Committee and subsequently approved by the Board of Directors at its meeting held on April, 17, 2015 in terms of Clause 41 of the Listing Agreement.
- The Board of Directors have recommended, subject to the approval of the shareholders at the ensuing Annual General Meeting, a dividend of 10% i.e. Rs.0.10 per Equity Share.
- The Company has been following the practice of publishing Consolidated Financial Results. The Standalone Financial Results are available on the Company's website i.e. www.deltacorp.in . The financial details on standalone basis are as under:

- The Consolidated Financial Statements are prepared in accordance with Accounting Standard 21 'Consolidated Financial Statement' and Accounting Standard 23 'Accounting for Investment in Associates in Consolidated Financial Statement' and Accounting Standard 27 'Financial Reporting of Interests in Joint Venture's issued by The Institute of Chartered Accountants of India.
- The unaudited financial results of two subsidiaries, two step down subsidiaries and one step down associate of the company have been consolidated on the basis of unaudited financial statement prepared by the management of the respective entities.
- In respect of an overseas subsidiary & its components, due to the differences with its local management, the Company is unable to obtain the financial statements / relevant information of such subsidiary & its components. The Company is in the process of resolving the differences. On account of non-receipt of the financial statements / relevant information, the Company could not consolidated these entities. The resulting impact on account of non consolidation of such entities, if any, is not quantifiable.
- Additional Finance cost of Rs.2,163.04 Lacs and additional Depreciation of Rs.1,240.26 Lacs related to "The Deltin" a five star hotel property of Company's Subsidiary at Daman is now charged to Profit and Loss account which were same kind of expenditure capitalised till March, 2014.
- The Allotment Committee of the Board of Directors of the Company at its meeting held on 3rd February, 2015 allotted 25,000 Equity Shares of Rs. 1/- each, to the option grantee, pursuant to exercise of option, under DELTA CORP ESOS 2009.
- 9 During the quarter under review, M/s. Atled Technologies Private Limited became Wholly Owned Subsidiary of the Company.
- 10 i) As regards auditor's observation with respects to utilization of MAT Credit Entitlement of Rs. 2,167.61 Lacs in the financial statement, as per management's future business projections, such credit will be fully utilized within the stipulated period. This being a technical matter, has been relied upon by the auditors.
 - ii) As regards Auditor's observation in respect to the consolidation of a subsidiary and it's components till 30th September, 2013 in the consolidated accounts. Due to the differences with its local management, the Company is unable to obtain the financial statements / relevant information of such subsidiary & its components. The Company is in the process of resolving the differences. On account of non-receipt of the financial statements / relevant information, the Company consolidated these entities based on the financial position as on 30th September, 2013. The resulting impact of this if any, is not quantifiable.
 - iii) As regards Auditor's observation in respect of a search and seizure was carried out u/s 132 of the Income Tax Act, 1961 (the Act) by the Income Tax Authorities on 29th April 2014 on the Company and its Subsidiaries. Consequently, the Company & its Subsidiaries have disclosed a sum of Rs.1694.02 lacs for earlier years. As such disclosed amount for earlier years does not affect the accumulated profits of the Company as on 1st April 2014, only such tax and interest of Rs. 573.74 lacs have been accounted for, which eventually gets adjusted towards the carry forward losses, of certain respective Subsidiaries. Hence, the net payment of income tax and interest thereon after adjustment of such losses aggregates to Rs. 261.29 lacs. Such disclosed amount is subject to final acceptance by the tax authorities u/s 143(3)/153A of the Act. However, the Company & its Subsidiaries does not expect any further liability on this account under the Act, if any, as well as under any other Act.
- Gains/ (Loss) from proceeds of partial liquidation of Kenyan subsidiary and difference on account of change in depreciation policy are disclosed under the head Exceptional Items.
- 12 The figures of last quarter are the balancing figures between audited figures in respect of the full financial year and the published year to date reviewed figures upto the third quarter of the current financial year.

13 Figures of the previous period have been regrouped / rearranged / reclassified / recasted wherever necessary.

- 1 The above audited results for the Financial Year ended March, 31, 2015, were reviewed and recommended by the Audit Committee and subsequently approved by the Board of Directors at its meeting held on April, 17, 2015 in terms of Clause 41 of the Listing Agreement.
- The Board of Directors have recommended, subject to the approval of the shareholders at the ensuing Annual General Meeting, a dividend of 10% i.e. Rs.0.10 per Equity Share.
- The management of the Company has carried out changes for depreciation on tangible fixed assets as per the provisions of Schedule II to the Companies Act, 2013. On account of the above change carried out depreciation for the current quarter is higher by Rs.54.74 Lacs and for twelve months is higher by Rs.278.58 Lacs.
- The Allotment Committee of the Board of Directors of the Company at its meeting held on 3rd February, 2015 allotted 25,000 Equity Shares of Rs. 1/- each, to the option grantee, pursuant to exercise of option, under DELTA CORP ESOS 2009.
- 5 i) As regards auditor's observation with respects to utilization of MAT Credit Entitlement of Rs.2,167.61 Lacs in financial statement, as per management's future business projections, such credit will be fully utilized within the stipulated period. This being a technical matter, has been relied upon by the auditors.
- ii) As regards auditor's observation with respect to a search and seizure was carried out u/s 132 of the Income Tax Act, 1961 (the Act) by the Income Tax Authorities on 29th April 2014 on the Company, its Subsidiaries. Consequently, the Company has disclosed a sum of Rs.238.92 lacs for earlier year. As such disclosed amount for earlier years does not affect the accumulated profits of the Company as on 1st April 2014, only such tax and interest of Rs. 81.21 lacs have been accounted for. Such disclosed amount is subject to final acceptance by the tax authorities u/s 143(3) /153A of the Act. However, the Company does not expect any further liability on this account under the Act, if any, as well as under any other Act.
- 6 Gains/(Loss) from proceeds of partial liquidation of Kenyan subsidiary and difference on account of change in depreciation policy are disclosed under the head Exceptional Items.
- 7 During the quarter under review, M/s. Atled Technologies Private Limited became Wholly Owned Subsidiary of the Company.
- The figures of last quarter are the balancing figures between audited figures in respect of the full financial year and the published year to date reviewed figures upto the third quarter of the current financial year.
- 9 As per Accounting Standard (AS) 17 "Segment Reporting", segement information has been provided in Consolidated Financial Results.
